TERMS OF REFERENCE/SPECIFICATIONS

1. PURPOSE

The appointment of the service provider to provide virtual streaming service for the Provincial Tourism Lekgotla scheduled for **26-27 August 2021**, Tiveka Game Lodge.

2. BACKGROUND AND OBJECTIVES OF THE LIMPOPO PROVINCIAL TOURISM LEKGOTLA

2.1 BACKGROUND

Limpopo Tourism Agency together with Limpopo Economic Development Environment and Tourism (LEDET) will host the Provincial Tourism Lekgotla to discuss several critical issues impacting on tourism both in the country and the Province.

It is imperative to note that in the last five years the National Tourism Sector Strategy sought to increase the number of tourists visiting South Africa or making trips throughout the country through implementing the 5-in-5 strategy (which is 5 million tourists in 5 years). The central objective was to increase the direct contribution of tourism to the economy from R118 billion to R302 billion by 2026 through collaborative planning and the implementation of agreed priority actions.

Some of the priority actions in terms of numbers were achieved, whilst there was a continuing gap on tourism infrastructure that should aid development. Given the COVID-19 pandemic in 2020, these goals may need to be revised as the numbers of international travelers have been reduced drastically, whilst the domestic trips may have taken a knock in the first half of 2020 when COVID-19 broke out.

2.2. OBJECTIVES OF THE LIMPOPO TOURISM LEKGOTLA

- To initiate and facilitate a conversation about the value of tourism and how to position itself within the COVID-19 recovery plan.
- To facilitate easy access through effective and efficient infrastructure, airlift, connectivity, and others.
- To increase domestic tourism trips (educate and create awareness of domestic tourism, tourism products and related services, particularly in the rural areas)

- To encourage domestic travellers (Visiting Friends and Relatives) to be tourists in their own province
- To enhance the visitor experience
- To improve destination management practices

2.3. IDENTIFIED AREAS OF DISCUSSION AT LIMPOPO TOURISM LEKGOTLA

- Covid 19 Tourism Recovery Plan
- Investment and partnership opportunities within the clusters
- An improved road network and signage of the province.
- Improved and affordable airlift (airlift strategy critical for the province)
- Access roads to affordable and quality standard accommodation
- Access to Information and Communication Technology (ICT)
- Tourism infrastructure funding (both public and private), and
- Intergovernmental relations on tourism infrastructure delivery.

LTA together with LEDET will convene the Limpopo Provincial Tourism Lekgotla under the theme “**Advancing Tourism Growth Through Investment and Partnerships.**”

The conference will be attended by 50-100/150 delegates participating in a hybrid format.

To conduct and professional run a successfully hybrid conference LTA will require the services of a service provider to assist with the Virtual Live Broadcasting/Streaming Services.

3. TERMS OF REFERENCE

The service provider should provide the following services:

- Facilitate and Coordinate with the venue management the virtual live broadcasting/streaming on all LTA/LEDET digital platforms such as twitter, Facebook, Instagram, zoom and Microsoft teams.
- Coordinate the participation of virtual delegates to the live event together with the Programme Director.
- Virtual recording of the conference.
- Provide a virtual record of the conference through a digital link and soft copy.
- Signal sender/receiver (greater than 40 megabytes per second)
- Onsite technical support

EVALUATION METHODOLOGY

In accordance with the Preferential Procurement Regulations, 2017, the bid evaluation process shall be carried out in three Phases namely:

- Phase 1 : Administrative Compliance
- Phase 2 : Evaluation on Functionality
- Phase 3 : Evaluation in terms of Price and Preference Point Systems

1. Phase 1: Administrative Compliance (Submission of compulsory proposal requirements by bidders and compliance to specification.)

The first phase of evaluation is checking and verification of all mandatory documents to be submitted by the bidders and compliance to specification.

If any of the following Bid Forms are not completed and signed or handed in with your proposal on closing date and time, your proposal will be immediately disqualified.

- **SBD 3.1** (Pricing Schedule) Make sure it is completed
- **SBD 4** (Declaration of Interest) Make sure it is signed.
- **SBD 6.1** (Preference claim form) Certified copy of BBBEE certificate to be submitted. Failure to submit, bidders will forfeit BBBEE Level of Contributions Points;
- **SBD 8** (Declaration of Bidder’s past supply chain management practices) Make sure it is signed.
- **SBD 9** (Bid rigging) Make sure it is completed and signed.

Only Certified copies or original documents will be accepted.

- **PLEASE NOTE:**
 - a) the bidder or any of its directors/shareholders is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
 - b) the bidder has not:
 - i) abused the Supply Chain Management System; or
 - ii) failed to perform on any previous contract and has been given a written notice to this effect;

- c) All corrections and scratching are initialled;
- d) Completion of the bid document using pencil not allowed, **BID DOCUMENT TO BE COMPLETED IN BLACK INK;**
- e) Scratching are done by putting a straight line through the corrected items;
- f) **THE USE OF CORRECTION FLUID WILL AUTOMATICALLY INVALIDATE YOUR BID;**
- g) Alterations to the bid document or submission of a copy of the original bid document will invalidate the bid;

Bidders that do not comply with the bid requirements may be regarded as non-responsive and may be disqualified.

2. Phase 2: Functionality

The assessment on functionality will be done in terms of the evaluation criteria and minimum threshold as specified. The minimum qualifying score for functionality is **60%** as set out below. Bidders who fail to achieve the minimum qualifying score on functionality will be disqualified for further evaluation of price and B-BBEE status.

The minimum qualifying score for functionality is **60%**.

3. Phase 3 : Evaluation in terms of Price and Preference Point Systems

Only bids that achieve the minimum qualifying score/percentage for functionality will be evaluated further in accordance with the 80/20 preference point system prescribe in Preferential Procurement Regulations 6 and 7.

Step 1: Calculation of Points for Price

- 1) The PPPFA prescribes that the lowest acceptable bid will score 80 points for price. Bidders that quoted higher prices will score lower points for price on a pro-rata basis.
- 2) **When calculating prices:**
 - a) Unconditional discounts will be taken into account for evaluation purposes; and
 - b) Conditional discounts will not be taken into account for evaluation purposes but would be implemented when payment is affected.
- 3) The formulae to be utilized in calculating points scored for price is as follows:

4) Points scored must be rounded off to the nearest 2 decimal places.

Step 2: Calculation of points for B-BBEE status level of contributor

Points will be awarded to a bidder for attaining the B-BBEE status level of contributor in accordance with the table below:

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.
